Subject: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your Larung Limestone Mine over an area of 4.76 Ha. in East Jaintia Hills district of Meghalaya.

Sir,

On perusal of the office records, the following provisions of MCDR, 2017 were found violated in your above mine.

Rule Number	Nature of violations observed
45(5) The holder of mining lease shall submit online returns in respect of each mine to the Regional Controller or any other authorised official of the IBM in the following manner, namely:- (b) a monthly return which shall be submitted before the 10 th day of every month in respect of the preceding month in electronic form along with a signed print copy of the same if it is not digitally signed, in the respective form.	The monthly return for the month of October/ November/ December 2017 has not been received yet in this office.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
