Sub :- Violation of provisions of Mineral Conservation and Development Rules, 1998 in respect of your Umrango Limestone Mine over an area of 35.0 Ha. Of M/s NECEM Cements Ltd. Dima Hasao District of Assam State

Sir,

The following provisions of MCDR 2017 (erstwhile MCDR 1988) were found violated in your above mine during the inspection on 14/8/2017 by the undersigned.

Rule 26(2)	An yearly report as per the format specified by the Indian Bureau of Mines, before 1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in approved mine closure plan has not been submitted by the owner, agent, manager or mining engineer to the Regional Controller of Mines
Rule 27(2)	Where financial assurance has already been furnished before commencement of these rules under sub-rule(1), an amount equal to the difference between the financial assurance due as on the date of notification of these rules and the financial assurance already furnished, shall be furnished to the Regional Controller of Mines, as the case may be, within a period of ninety days from the date of notification of these rules, has not been furnished till date.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of Mineral Conservation and Development Rule, 1988.

03. You are advice to submit the return within a week from the date of issue of this letter.
