Subject: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your New Umranshu limestone mine over an area of 31 Ha. in Dima Hasao district of Assam.

Sir,

On perusal of the office records, the following provisions of MCDR, 2017 were found violated in your above mine.

Rule Number	Nature of violations observed
11(3) Every approved mining plan shall be subjected to review & updation in every five years as per the provision of sub rule 1 of rule 17 of Minerals (Other than Atomic & Hydrocarbon Energy Minerals) Concession Rules 2016.	After approval of the last review of mining plan vide letter dated 27.5.2003, no document has been submitted to this office regarding review & up-dation of the mining plan for the next five years & further onwards.
27(2): Where financial assurance is required to be furnished by the holder of the mining lease under sub-rule (1), such amount of financial assurance shall be submitted to the authorised officer, as the case may be, in the form of a bank guarantee in the format specified by the Indian Bureau of Mines:	guarantee has been submitted to this office till date.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
