Sub: Violation of provision of MCDR, 2017 in respect of your Umsoo Mootang Block-I Limestone Mine (38MEG03010) over an area of 4.90 Hect. in Thangskai Village, Taluka-Nurpuh, East Jaintia Hills district of Meghalaya State.

Sir,

The following provisions of MCDR 2017 (erstwhile MCDR 1988) were found violated in your above mine during the inspection on 11.08.2017 by the undersigned in presence of the mine officials Sri Manoj Kumar Sinha (Mines Manager) and Sri Neelabh Saxena (Geologist).

Rule 11(1)-

Mining operations in the mine are being carried out in violation of the following provision of the approved Review of Mining plan.

- i) Present location of waste dump is not as per the proposed location in the approved development plan and section for the year 2016-17.
- ii) Plantation has no carried out along the safety barrier from A-1 to E-1 mining lease pillar as proposed in the approved development plan and section for the year 2016-17.

02. In this connection it is brought to your notice that the above violation constitutes an offence punishable under rule 58 of MCDR 1988.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.




