Sub: Violation of provision of MCDR, 2017 in respect of your Lumshnong Limestone Mine (38MEG03001) over an area of 4.90 Ha. in village Lumshnong, Taluka- Nurpuh, East Jaintia Hills district of Meghalaya State.

Sir,

The following provisions of MCDR 2017 (erstwhile MCDR 1988) were found violated in your above mine during the inspection on 10.08.2017 by the undersigned in presence of the mine officials Sri A. K. Pathak (Mines Manager).

Rule 11(1)-

Mining operations in the mine are being carried out in violation of the following provision of the approved Review of Mining plan.

- i) Fencing around the quarry has proposed before starting of reduction of benches, but after reduction of bench width, fencing around the quarry has not done till date.

Rule 26(2)-

An yearly report as per the format specified by the Indian Bureau of Mines , before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in approved mine closure plan has not been submitted by the owner, agent, manager or mining engineer to the Regional Controller of Mines.

Rule 27(2)-

Where financial assurance has already been furnished before the commencement of these rules under sub-rule (1), an amount equal to the difference between the financial assurance due as on the date of notification of these rules and the financial assurance already furnished, shall be furnished to the Regional Controller of Mines, as the case may be, within a period of ninety days from the date of notification of these rules, has not been furnished till date.

Annual Returns for the year 2016-17 has not submitted to the Regional Controller of Mines till date.

02. In this connection it is brought to your notice that the above violation constitutes an offence punishable under rule 58 of MCDR 1988.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.


