Sir,

The following provisions of MCDR 2017 (erstwhile MCDR 1988) were found violated in your above mine during the inspection on 12.08.2017 by the undersigned in presence of the mine officials Sri Manoj Kumar Sinha (Mines Manager, Block-I) and Sri Neelabh Saxena (Geologist, Block-I).

Rule 55 (1)-

Every mining lease shall employ, in case of category 'A' mine, a whole time mining engineer and a geologist, shall have minimum five years of professional experience of working in a supervisory capacity in the field of mining;

As per annual return 2016-17, Sri S. G. Vastrad is the statutory geologist for the above said mine, who was neither present during inspection nor any official document was found as he is presently working.

- 02. In this connection it is brought to your notice that the above violation constitutes an offence punishable under rule 58 of MCDR 1988.
- 03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
