Sub: - Violation of provision of MCDR, 1988 in respect of your Komorrah Limestone Mine over an area of 240.55 ha. in East Khasi Hills district of Meghalaya State.

Sir,

The provision of the following rules of Mineral Conservation and Development Rules, 1988 (MCDR, 1988) were found violated in the above mine during inspection on 29/12/2016 by the undersigned.

Rule 13(1)-

Mining operations in the mine are being carried out in violation of the following provision of the approved Review of Mining plan.

I. In para 1(i) Page no. 38 of approved Review of Mining Plan exploration is proposed by drilling 3 bore Hole of 35 mtr. Depth but proposed exploration was not yet commenced.

In para 2(a), mining is proposed in band no.1 only but during inspection of mines it was observed that mining is carried out in number of scattered pits in addition to band no.1 which is not proposed in the approved Review of Mining Plan

In para 2(b) the yearwise production was proposed 1,25,000 Tonne for the year 2015-16 and 1, 50,000 Tonne for the year 2016-17, whereas during the year 2015-16 only 43569 Tonne of limestone produced. The year wise proposed production as well as year wise excavation programme proposed in Review of Mining Plan have not been achieved.

Rule 45

While examination of Annual Returns for the year 2015-16 the following deficiencies were observed

- i) As per monthly return (F-8) the production of 2015-16 is 43736.740 tonnes but as per annual return (H-
- 8) the production of 2015-16 is 43569.080 tonnes.
- ii) As per monthly return (F-8) the dispatch of 2015-16 is 41386.00 tonnes but as per annual return (H-8) the dispatch of 2015-16 is 40878.00 tonnes.
- iii) As per monthly return (F-8) the closing stock on 31st March, 2016 is 4083.020 tonnes but as per annual return (H-8) the closing stock on 31st March, 2016 is 4423.360 tonnes.
