Sub: Violation of provisions of Mineral Conservation and Development Rules 1988 in respect of Umsoo-Mootang Block-IV Limestone Mine of M/s Adhunik Cement Ltd, East Jaintia Hills District of Meghalaya State.

Sir,

The provision of the following rules of Mineral Conservation and Development Rule1988 (MCDR, 1988) were found violated in the above mine during inspection on 6/08/2016 by the Undersigned:

Rule 13(1): Mining operations in the mine are being carried out in violation of the following provision of the approved Scheme of Mining.

- (i) In the first year (2015-16) mining is proposed by forming of 3(Three) benches at 697-688, 688-679 & 679-670 m RL. But during inspection it was observed that mining operation is carried out by formation of single bench in most part of the pit.
- (ii) In first year (2015-16) plantation was proposed along the lease boundary over statutory barrier by planting of 120 no. saplings but during inspection no plantation was observed along the statutory barrier.

- (iii) During first year (2015-16) total production of limestone was proposed 700022 T. But only 442070 T limestone was mined out.
- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under rule 58 of MCDR, 1988.
- 03. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 days (forty five) days from the date of issue of this letter.
