In this regard you are advised to rectify the deficiencies and submit final three bound copies and two soft copies in DVD, texts in form of MS word and plans in Auto CAD and JPG format of the Review of Mining Plan along with Progressive Mine Closure Plan and Bank Guarantee of Rs. 5,00,000/- (Rupees Five Lakhs only) as financial assurance for the minimum amount for category 'B' mines for the plan period as per Rule 27(1) of MCDR 2017 to this office within 15 (Fifteen) days from the date of issue of this letter for further necessary action. The Para-wise clarification and the manner in which the deficiencies are attended should be invariably being given while submitting the Review of Mining Plan.

It may be noted that no further extension of time in this regard will be entertained and the document will considered for rejection if not submitted within above due date and the deficiencies are not attended properly.

Scrutiny Comments on Draft Review of Mining Plan with Progressive Mine Closure Plan of Sillimanite Deposit over an area of 4.64 Ha in village Langumshing, P.S-Nongstoin, Dist- West Khasi Hills, Meghalaya of M/s. Sangriang Mining Enterprises, Submitted by Abdul Motin Barbhuiya (Qualified Person) under Rule 17 (1) of MCR 2016 & 23 of MCDR 2017.

### **TEXT**

- 1. The statutory rules and provisions under which the review of mining plan along with progressive mine closure plan has been prepared and submitted are incorrectly quoted on the cover page, certificate and other places of the plan, which needs to be rectified i.e. under Rule 17(1) of MCR 2016 and Rule 23 of MCDR 2017.
- Consent Letter/Undertaking/Certificates needs to attach after PMCP chapter (Part-B) as per IBM manual on appraisal of mining plan 2014.
- 3. Individual chapters and points in-between and required maps should be furnished as per IBM manual on appraisal of mining plan 2014.
- 4. Registered No. under Rule 45 of MCDR 1988 needs to be furnished.
- 5. Documentary evidence of approved mining plan/ scheme of mining/review of mining plan along with PMCP need to be annexed and annexure no should be furnished in the text.
- 6. Reason for non submission of review of mining plan along with progressive mine closure plan in due time needs to be furnished in text.
- 7. Copy of the suspension letter to be annexed and annexure no should be furnished in the text.
- 8. Details year-wise proposed v/s achieved production during the present approved scheme period needs to be furnished in a separate table.
- 9. Parameters considered for resource/reserve calculation has not been discussed with relevant information. Further the resource/reserve estimated in surface area method, which needs to be calculate by using cross-section method and should be done as per UNFC.
- 10. Method of mining (Both existing & proposed) should describe elaborately. Further year-wise development program should be furnished in a increasing manner and needs to be rectified accordingly.

- 11. Conceptual mining Plan: dimension of ultimate pit boundary, capacity of ultimate waste dump if any should be furnished in text.
- 12. Others: Employment potential: the workforce proposed to be deployed in the mine to achieve the daily production target should be classified under three different categories such as skilled, semi-skilled and un-skilled separately.
- 13. PMCP: year wise proposal of afforestation program, retaining wall, garland drains, settling tank, etc should be furnished under the summary of year-wise proposal for item no. 8.3 for the review of mining plan period.
- 14. As per Rule 27 of MCDR 2017, Bank guarantee of minimum amount of Rs. 5,00,000/-(Rupees Five Laks) for category 'B' mines needs to be submitted to RCOM, IBM, Guwahati
- 15. Annexure submitted with the mining plan are obscure. Legible copy of annexure to be submitted.
- 16. Qualified person is advised to signature with name mentioned below in each and every page of the document along with the annexure.
- 17. Beside the above typographical errors in the draft review of mining plan should be rectified.

- 1. Authenticated Lease map to be furnished.
- 2. Geological features from surface map should be removed.
- 3. Strike & Dip shown in index but not shown in geological map.
- 4. Environment Plan, Financial Assurance Plan, etc are to be furnished (as IBM manual on appraisal of mining plan 2014).
