Sub: Violation of provisions of MCDR, 2017 in respect of Budawada Limestone mine of M/s Ultratech Cement Limited over an extent of 629.22 ha in Budawada (V), Jaggayyapeta (M), Krishna District, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in the above mine during the inspection on 08.03.2018 by undersigned in the presence of Sri K.N.Sidda Reddy

Rule No.	Nature of Violation observed
Rule 11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. However it is noted that the exploration activity has not been under taken as per the Mining Plan approved vide letter dated 28.04.2017 for completing the backlog of exploration for the year 2016-17 and the exploration for the year 2017-18.
02.	In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017. Besides, inability to comply the provisions of rule 11(1) is also liable for suspension of mining operations under provisions of rule 11(2) of MCDR '88.
03.	You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
