Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of Jaggayyapeta Limestone mine of M/s RINL over an extent of 1295 ha in Jaggayyapeta (V) & (M) Krishna District, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in the above mine during the inspection on 06.03.2018 by undersigned in the presence of Sri Vijay Kumar, Mining Engineer

Rule No.	Nature of Violation observed
Rule 40	Every holder of prospecting licence or a mining lease shall take all possible measure to keep air pollution due to fines, dust, smoke or gaseous emissions during prospecting, mining, beneficiation or metallurgical operations and related activities within permissible limits. However it has been observed that air monitoring has not been done to establish whether the air pollution level is within permissible limits or not.
Rule 41	The holder of prospecting licence, prospecting license cum mining lease or a mining lease shall take all possible measure to control or abate noise arising out of prospecting, mining, beneficiation or metallurgical operations at the source so as to keep it within the permissible limits. However it has been observed that air monitoring has not been done to establish whether the air pollution level is within permissible limits or not.
Rule 56(2)(f)	The Geologist appointed as per rule is responsible for periodic updating of minerals resources as per drilled boreholes and calculation of ore reserves and it's grade. However the same data has not been found during the inspection.

02. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017.
03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
