Subject: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect to **Inspection of Jitti Iron Ore Mine (27.05 Ha), M/s Pacific Exports, Village- Jhitti, Tahsil- Sihora, District- Jabalpur (M.P.)**.


Sir,

The undersigned has inspected your mine on 21/01/2021 for processing of submitted draft review of mining plan document in the presence of your representatives Sh. Viond Choudhary (Agent- Mines), Sh G. P. Chaturvedi (Mine Manager) and other officials. Following provisions of MCDR 2017 were found violated in your mines during inspection.

Rule No	Nature of violation observed in detail
Rule 11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016. The document of above mentioned mine was approved vide letter No.- MP/Balaghat/Manganese /RMP-21/16-17/364 dated 19/01/2011 incorporating proposal of working from 2016-17 to 2017-18. a) Exploration was not done against the proposal of 09 nos. of exploratory bore holes for 2019-20. b) Excavation was observed within 7.5m barrier zone in Southern and North-West side of ML without any proposal in approved document.
Rule 26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof: The yearly report in respect of rule 26(2) of MCDR 2017 has not been submitted for the previous approved plan period.
Rule 33	Copies of plans and sections to be submitted – The holder of mining lease shall on or before the 30th day of the June every year submit to the authorized officer, as the case may be, and the State Govt. a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. Copies of plans and sections under rule 32 of MCDR-2017 have not been submitted.

- In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.
- The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.
- You are advised to rectify the violations of abovementioned rules immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
