Subject: - Violation of provisions of Mineral Conservation & Development Rules, 2017, in respect of your
Budgauna Limestone Mines (area-60.671 Hect.) in District of Sidhi in M.P. State.

Dear Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during MCDR inspection on 12.01.2021 by the undersigned in presence of Shree Mukesh Kumar Thawait.

Rule 11(1) MCDR 2017	<p>1. Mining operations under mining lease.-(1) No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016.</p> <p>(2) If the mining operations are not carried out in accordance with the approved or certified mining plan or any information contained in the mining plan is found to be incorrect, misleading or non-compliant with applicable laws including these rules, the competent authority may by order, suspend all or any of the mining operations and permit continuance of only such operations as are required to restore the conditions in the mine as envisaged under the approved or certified mining plan or modified mining plan, for the purpose of restoration to the extent possible :</p> <p>(1) 7 Exploratory Bore holes are not drilled against the proposal.</p> <p>(2) Development and production are very less than planned – Production : 270000 T/ 6114 T Development : 145619 M³/ 3900 M³</p> <p>(3) Retaining wall along the waste dump is not constructed as per proposal.</p> <p>Thus there is violation of this rule .</p>

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.


