Sub:Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of Sri Lakshmi Iron Ore Mine over an extent of 88.395 ha in Chabali Village, Pendlimarri Mandal, YSR Kadapa District, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017 (MCDR, 2017), were found violated in your above mine during the inspection on 21.02.2020 by the undersigned in the presence of Shri. Y.M.Mahesh, Mines Manager.

Rule No-	Nature of violation
55(1)	<p>For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules – every holder of a mining lease shall employ, in case of- (i) category ‘A’ mines, a whole-time geologist.</p> <p>The Geologist appointed was not having experience of 5 years geologist as per the rule 55 (1) 3 of MCDR 2017.</p>
19 (1)	<p>Where heavy earth moving machinery is used in mines, the holder of a mining lease shall maintain log books duly authenticated by the Manager or Mining engineer of such mines in respect of each machine showing date-wise account of hours worked, hours not worked, reasons for non-working, consumption of fuel or energy and lubricants and output of the machine during the corresponding working hours.</p> <p>The log books were not maintained as per the contents mentioned in the Rule No.19 (1).</p>
31 (4)	<p>The plans and sections required under these rules shall be maintained up to date within three months in case of category ‘A’ mines as referred to in clause (a) of sub-rule of rule 55, and within twelve months in the case of any other mine.</p> <p>However during inspection it was noticed that plans and sections were not updated as per Rule No. 31(4).</p>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule- 62 of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty five) days from the date of issue of this letter.
