Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of Putikavalasa Manganese Mine over an extent of 21.77 ha in Putikavalasa Village, Saluru Mandal, Vizianagaram District, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017 (MCDR, 2017), were found violated in your above mine during the inspection on 19.03.2020 by the undersigned in the presence of Shri.Sudhakar, Mine Representative & Shri.Siva Prasad, Mine Manager.

Rule No.	Nature of violation
11 (1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section(2) of section 5. It was proposed to carry out exploration with core boreholes in the plan period i.e., in 2018-19 :12 Nos., Nos., 2019-20 :15 Nos. However during inspection, it was observed that no such exploration by drilling of core boreholes was carried out.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule- 62 of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty five) days from the date of issue of this letter.
