Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of Ravirala Limestone Mine over an extent of 60.72 ha in Ravirala Village, Jaggayyapeta Mandal, Krishna District, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017 (MCDR, 2017), were found violated in your above mine during the inspection on 19.12.2019 by the undersigned in the presence of Shri. Jani Reddy, Agent & Sr. Dy.G.M (Mines).

Rule No-	Nature of violation
11 (1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared <del>and certified in accordance with the system established by the State Government</del> pursuant to the proviso to clause (b) of sub-section(2) of section 5.  Retaining wall and garland drain was proposed all around the dump yard to prevent erosion but during inspection it was not found to be constructed.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule- 62 of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty five) days from the date of issue of this letter.
