<u>Subject:</u> Violation of provisions of MCDR 2017 in respect of Kumaraswamy Iron Ore Mine (M.L. No. 1111) of M/s NMDC Limited., over an extent of 647.50 ha, in Kammadaruvu & Deogiri Villages, Sandur Taluk, Ballari district, Karnataka State...Reg.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017 were found violated in your above mine during the inspection on 8/11/2019 by the undersigned in the presence of Mines Manager S/Shri Dhiren Bhushan & R. K. Tekaml-Mining Engineer, Dr. D. N. Subramanyam, Geologist.

Rule 11(1)	It was proposed in the approved Modification & Review Of Mining Plan vide letter No. 279/290/91/BNG dated 06/07/2017 for the period 201-18(i.e. 01.05.2017 to 2021-22(31.03.2022) The deviations observed in mining operations vis-a-vis approved document are given below: (i). It was proposed to drill 12 nos. of bore holes for the year 2019-20, which was not yet drilled as envisaged in the approved document.
45(5) (b)(i)	In part-I, under Sl.No. 12(vi), reported 7.880 ha area is utilized for mineral storage both in forest land & in non forest area as per the year 2018-19. But in the approved mining plan approved vide letter no.279/290/91/BNG dated 6/7/2017, in para 8.6, under financial assurance 10.64 ha has been put to use at the beginning of the review & updation of Mining Plan, how this difference comes maybe explained. (ii). In part-VI, (2), under production & stocks, opening & closing stocks in dump workings is reported as 4191.040 tonnes, this refers to which dump number is not indicated for reference.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 03. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
