The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 14.01.2020 by undersigned in presence of S.B Nagnur-QP & Vijay Bhaskar Reddy- Owner's representative.

Rules	Nature of Violations observed
45(5)	Following discrepancies are observed in AR 2018-19. <u>Part-I:</u> 1. The date of execution of mining Lease deed is reported as 14/2/2009 in AR 2018- 19-I (11) which is incorrect, as no executed lease deed for the second renewal w.e.f. 8.3.2002 was found during inspection.
	 The date of transfer is reported as 01/1/1970 in I (10) of AR-2018-19, which is incorrect .There is no transfer of this lease.
	3. The Land use is reported as 0 hectares for all categories I(12) of AR-2018-19 which is incorrect.
	Part-V: The reserves and the resources are reported as 0 tons in AR 2018-19 which is incorrect.

- 02. It is brought to your notice that violation of the above Rule constitutes an offence punishable under Rule 62 of MCDR, 2017.
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
