The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 14.02.2020 by undersigned in presence of the lessee representatives Mr. JayantiLal Jain, Mr. Shyam Sunder & Mr. BandarupalliRamanjaneyulu.

Rules	Nature of Violations observed
45(5) (b)	<p>‘The holder of a mining lease shall submit online monthly return, which shall be submitted before the tenth day of every month in respect of the preceding month in electronic form along with a signed print copy of the same if it is not digitally signed, in the respective Form’.</p> <p>The monthly Returns have not been submitted from Oct-2015 onwards as per provision of this Rule.</p>
45(5) (c)	<p>‘The holder of a mining lease shall submit online Annual return, which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same if it is not digitally signed, in the respective Form’.</p> <p>The Annual returns have not been submitted from 2015-16 onwards as per the provision of this rules.</p>

02. It is brought to your notice that violation of the above Rule constitutes an offence punishable under Rule 62 of MCDR, 2017. Further the violation of Rule 45(5) of MCDR also attracts provision of Rule 45(7) of MCDR 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty Five) days** from the date of issue of this letter.
