Subject: Violation of provisions of MCDR 2017 in respect of Sankalapuram Iron Ore Mine (M.L. No. 2682) of M/s. Rai Bahadur Seth Shreeram Narasingdas Pvt.Limited., over an extent of 111.09 ha, in Sankalapuram Village, Hosapete Taluk, Ballari district, Karnataka State...Reg.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017 were found violated in your above mine during the inspection on 05/11/2019 by undersigned in the presence of Mines Manager S/Shri **Gopal Joshi, Mining Engineer-**Pradyumna.R.Urs.

(i). In part-I, under Sl. No. 12(iv), for rehabilitation, it is reported as 9.44 ha, outside forest area, and for waste disposal, it is reported as 18.167 ha, if it is not undertaken reclamation & rehabilitation together, than the extent of the area need to be reflected along with waste dump only and not separately with rehabilitations. In the light of the above remarks, this should be attended in the approved review and updation of Mining Plan.
(ii). IN part-V, para 4.2©(i), quantity of back filling reported for the year is 41,500t & cumulative quantity is 49,500t, but this quantity reported is not clear in which location this quantity has been used as back filling materials may be explained.

02. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.

03. You are, therefore, advised to rectify the above violation immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
