The following provisions of Mineral Conservation and Development Rules 2017 were found violated in your above mine during the inspection on 6/11/2019 by the undersigned in the presence of Mines Manager S/Shri P.R.V. Prasad, Mining Engineer-B. Sananda & Geologist –S.M. Hegde.

	It was proposed in the approved Mining Plan approved vide letter No.
Rule	279/327/92/BNG/735 dated 7/2/2019 for the five years period 2018-19 (Jan 2019 to
11(1)	March 2019) to 2022-23(22.09.2023). The deviations observed in mining operations vis-
	a-vis approved document are given below:
	(i). It was proposed to develop & produce iron ore and waste from the north & the central
	blocks, but during the inspection day it was found that the mine is working only in the
	north block and not in the Central block as envisaged in the approved Review & Up-dation
	of Mining Plan.
	(ii). As per the approved Mining plan, during the year 2019-20, there is a proposals to start
	back filling & the production simultaneously from the north block, but the production is
	going on in the north block, but the back filling is yet to start.
