Sub: Violation of the provisions of Mineral Conservation and Development Rule 2016 in respect of Jonnagiri Gold Mine over an extent of 597.82 Ha. in Pagadrayi, Jonnagiri, yerragudi village of Tuggali Mandal in Kurnool District of Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in the above mine during the inspection on Sri Mr. M Masanam Saravanan, Mining Engineer, Mr. Karthikeyan.C, Geologist and other representatives were present during the inspection.

Rule No.	Nature of Violation
11(1)	The mining operations were not carried out in accordance with the document approved vide this office Lr. No. AP/KNL/MP/Gold-1/Hyd dated 13/04/2018 to the extent indicated below 1. The exploration work has not been under taken as per proposal. 68 boreholes and 12 trenches were also proposed were proposed in 2018-19 but only two trenches have been made and the result there of too have not been reported. 2. The mining operation for production development and corresponding environment protection measures like afforestation, mineral beneficiation work including the site preparatory work has not been found to be commenced.
26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof. However the same has not been submitted.

- 2 In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017. Inability to comply the provision of Rule 11(1) and is liable for suspension of mining operations under rule 11(2) of MCDR, 2017.
3. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
