Subject: Violation of provisions of MCDR 2017 in respect of Kalburgi Cement Limestone Mine (ML No.2612), M/s Kalburgi Cement Pvt. Ltd., Extent 446.77 Ha., located near Chatrasala Village, Chincholi Taluk, Kalburgi District of Karnataka State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 24.10.2018 by the undersigned and Shri Rohita Sethi, Asst. Mining Engineer in presence of Shri G. Sudhakar - Mines Manager, K. Nagaraja Rao –Geologist and other mining officials:

Rules	Nature of Violations observed
11(1)	As per the approved Modification of Review and Updation of Mining Plan, approved by IBM
	vide letter no. 279/1030/2009/BNG dated 18/05/2017, for the period of 2017-18 to 2018-19:
	a. 03 million tonnes of limestone production has been proposed during F.Y. 2017-18, against
	which 3.098 million tones of production have been reported.
	b. Constructions of two settling ponds were proposed as a part of environment protective
	measures during F.Y. 2017-18, but during site inspection it was observed that no settling
	ponds were constructed so far.

- 02. It is brought to your notice that violation of the above Rule constitutes an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
