महोदय/Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 21.06.2019 by undersigned in presence of S/Shri Avinash Morey-Qualified Person, Seshagiri Samji-Mines Manager and other mining officials:

11 (1)	As per the approved Scheme of Mining, approved by IBM vide letter no. 279/350/92/BNG
	dated 29/03/2016, for the period of 2016-17 to 2020-21:
	1. As a part of Reclamation and Rehabilitation programme, construction of 430m of
	Garland Drain (GD-1) has been proposed by the lessee to complete with-in 6 years
	(i.e. from 2014 to 2020); but so far lessee has completed 230m of Garland Drain in
	the lease area.
	2. Construction of 35 nos. of brush wood check dams (BWCD) has been proposed by
	the lessee to complete with-in 6 years (i.e. from 2014 to 2020); but so far lessee
	has constructed 6 nos. of BWCD in the lease area.
35 (2)	High resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on
	the scale of cadastral map, as on 31st March for that financial year, covering the mining
	lease and an area of 2 kilometres from the lease boundary was not submitted to the
	Regional Controller of Mines, IBM-Bangalore.

- 02. It is brought to your notice that violation of the above Rule constitutes an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
