महोदय/Sir,

Undersigned inspected your above mine on 27.08.2019 in presence of mine officials Shri .R Shivananda Reddy - Mines Manager & Sri. Vinod kumar deshmukh- Mining Engineer and violation letter of even number dated 11.09.2019 was issued for below mentioned rule of Mineral Conservation & Development Rules, 2017

Rule	Nature of violations observed
55	Whole time Geologist with minimum five years of professional experience of working in a supervisory capacity in the field of mining has not been appointed.

- 02. Till date you have not complied the pointed out violation and the reply received from you vide your letter dated 24/10/2019 has been examined and is not found satisfactory in respect of Rule 55.
- **03.** It is again brought to your notice that these violations constitute an offence punishable under rule 62 of MCDR 2017. On non compliance of the above provisions of MCDR 2017, the mining operation can be suspended under the rule 11(2) of the above mentioned rules.
- **04.** You are therefore, directed to **show cause** within a period of 30 (thirty) days from the date of issue of this letter as to why your mine should not be suspended for the above offence.

05. Please note that no further notice will be given to you in this regard.
