	During the year 2018-19, only 1, 01,778 Tons was produced against the proposal of 6, 50,000 Tons, thereby resulting in (-) 84% deviation.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.Further, the violation of Rule 11(1) may also attract
