Inspection report cum scrutiny comments on the Modified Mining Plan by M/s. My Home Industries Private Limited for Gamalapadu Limestone Mine (374.58 Hectares) of Gamalapadu Village, Dachepalli Mandal, Guntur District, Andhra Pradesh after field inspection dated 18/02/2020.

#### General

- 1. The reasons mentioned for submitting modification of Mining Plan is not plausible. Elaborate justification should be submitted.
- 2. The modifications in the production schedule for the retrospective period i.e., 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> year of the approved plan period is not acceptable, therefore to be deleted.
- 3. Proposal for exploration, excavation etc., and all other chapters for the last year of the plan period i.e. 5<sup>th</sup> year shall be recasted and be submitted as per the IBM manual on appraisal of Mining Plan.
- 4. In page no. 5 the Mine name, its postal address and location shall be mentioned instead of firm details.
- 5. During field inspection it was found that boundary pillars were not erected and maintained in the lease area.
- 6. During field inspection it was found that TBM is not erected as mentioned in the plan submitted.
- 7. The boundary pillar coordinates certified by the state government shall be submitted.
- 8. Proposed date of opening of mine shall be submitted.

#### Review of mining plan

- 9. **Exploration**: During field inspection it was noticed that no boreholes were drilled as per the proposal given in approved Mining Plan. To be justified.
- 10. **Afforestation**: During field inspection it was noticed that no afforestation done as per the proposal given in approved Mining Plan. To be justified with proper reasoning.
- 11. **Exploitation**: During field inspection it was noticed that no development and production carried out as per the proposal given in the approved Mining Plan. To be justified.
- 12. **Environmental Parameters**: No monitoring is carried out for quality of air, quality of water, noise and ground vibrations.

### **Geology & Exploration:**

- 13. Lithological sequence and its description shall be submitted correctly.
- 14. The pits/wells present in the lease area shall only be submitted.
- 15. NABL certification for analyzing the limestone samples shall be submitted.
- 16. Core boreholes shall be proposed for carrying out the detailed exploration (G1 level) over the entire potentially mineralized area under the mining lease for the modified plan period shall be submitted.

# **Progressive Mine Closure:**

17. During field inspection, human settlements were found within the lease area and the same was shown in the plan submitted. Whereas it is not mentioned in the human settlements heading at page no. 64.
