Sub: Violation of provisions of MCDR, 2017 in respect of Nagarur Limestone Mine of over an extent of 4.95 ha in Nagarur (V) Yadiki (M) Anantapur ,Dist Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017, were found violated in your above mine during the Review of Mining Plan inspection on 3.4.2018 by Smt. Ch.Suseela, Assistant Mining Geologist of this office accompanied by Sri P.Manoj Kumar, Son of the lessee and Sri.P.R.Mishra, Qualified Person.

45(5)(b) (ii)	The owner, agent, mining engineer or manager of every mine, shall submit online to the Regional Controller of Mines in the Indian Bureau of Mines or any other authorised official of the Indian Bureau of Mines , returns in respect of each mine, in the following manner, namely:- (i) A monthly return which shall be submitted before the 10th day of every month in respect of the preceding month in electronic form, along with a print copy of the same	Monthly returns from April,2017 and onwards have not been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad so far, as required under this rule.
45(5)(c) (ii)	The owner, agent, mining engineer or manager of every mine, shall submit online to the Regional Controller of Mines in the Indian Bureau of Mines or any other authorised official of the Indian Bureau of Mines , returns in respect of each mine, in the following manner, namely:- (i) An annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a print copy of the same.	Annual Returns since the year 2016-17 and 2017-18 have not been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad, so far, as required under this rule.

02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-62 of MCDR, 2017. Besides, inability to comply the provision of Rule 45(5) is liable for suspension of mining operations under Rule Rule 45(7) (i)(a) of MCDR,2017.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
