On examination of the office records following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine:

RULE NO.	NATURE OF VIOLATION OBSERVED		
11(1)	No holder of mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. On perusal of office records, it has been found that Modified Mining Plan of this mine was approved by this office vide letter no 614(2)/MP-B-284/08-DDN dated 26.04.2017. Proposed production as per approved Modified Mining Plan and actual production as per return year 2017-18 submitted by you achieved is as follows

	Thus, excess production was done in violation of approved quantity of production from your mine.		

- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 3. Mining operations can be suspended as per rule 11(2) in case of non compliance of the violated rule 11(1)
- 4. You are therefore directed to show cause notice within 30 days of issue of this letter as to why you should not be prosecuted for the above offence and /or mining operation can be suspended under statutory provisions.
