





Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Mattan Limestone Mine over an area of 4.844 ha located near Village- Mattan Martand, Tehsil and

District-Anantnag of J&K-U.T

महोदय Sir,

On examination of the office records following provisions of the Minerals Conservation and Development Rules, 2017 were found violated in your above mine:

11(1)	No holder of a mining lease shall correct the No holder of a mining lease shall correct the No.
	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. On examination of no 614(2)/MS-B-214/12-DDN dated 29.11.2016 vis-à-vis actual production as per statutory Returns is as follows:

33	Thus the mining operations were carried out in contraventions of the proposals in above referred mining plan. The holder of a mining lease shall, on or before the 30 <sup>th</sup> day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rules for the year 2017-18 and 2018-19.
45(5)(b)	Monthly returns have not been submitted by the lessee to the Regional Controller/authorized officer of Indian Bureau of Mines for months from July 2019 onwards
45(5)(c)	Annual returns for the year ending 31st March 2019 has not been submitted by the lessee to the Regional Controller/authorized officer of Indian Bureau of Mines.

In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62

3. Mining operations can be suspended as per rule 11(2) in case of non compliance of rule 11(1).

4. May Advise the State Government to order suspension of all mining operation in the mine as per provision of Rule 45(7), in case incomplete or wrong or false information has been furnished in statutory returns or fails to submit

5. May initiate appropriate action in accordance with any competent orders/directives etc.

6. You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted and / or why mining operation can be suspended under statutory provisions and/or why not any other action can be initiated in accordance with any competent orders/directives. 7. Please note that no further notice will be given to you in this regard.
