Table scrutiny comments on Modification of Review of Mining Plan of Gamalapadu Limestone Mine (374.58 Hectares) of M/s. My Home Industries Private Limited in Gamalapadu Village, Dachepalli Mandal, Guntur District, Andhra Pradesh.

General

1. Status of implementation of CCOM Circular no. 2/2010 to be submitted.
2. Color photographs should be enclosed in the document for easy reference pertaining to boundary pillars, afforestation, core logs, ground control points etc.
3. Reason for modification in the approved mining plan be submitted with due justification.
4. Details of the recent approved Review of mining plan details shall be submitted in the introduction chapter at page no.4.

Review of mining plan

5. Review of the earlier approved mining plan shall be submitted.

Geology & Exploration

6. Revised exploration proposal for the entire mineralized area and commitment to complete the exploration shall be submitted accordingly.
7. The total Reserves and Resources in the mining lease area with average grade shall be submitted as per IBM manual of appraisal of mining plan 2014 in page no.46.

Mining

8. As per the supplementary agreement to MDPA, the limestone production will reach the requirement of clinker capacity of 1.65 MTPA in the 10th year after execution of mining lease. Hence production proposal shall be submitted accordingly.
9. Temporary stacking of limestone during the plan period shall be submitted in the relevant chapter.

Conceptual plan

10. Annual production capacity for which the mine is planned and designed to be mentioned explicitly. The time schedule by which the mine will attain its rated capacity has to be submitted.
11. Conceptual plan to be prepared for the entire lease area showing UPL, life of the mine, conceptual exploration, pit dimension, land use pattern, status of reclamation and rehabilitation, land use, position of pit, dumps, dump re-handling proposals, green belt development etc. at the end of this 5 year period and at the end of the lease period.

Mine Drainage

12. As per the proposal, mine workings will intersect the ground water table during the plan period. Status of permission from CGWA for working below water table shall be submitted.

Progressive Mine Closure:

13. Summary of year wise proposal of protective measures for reclamation and rehabilitation shall be submitted for the total plan period.
14. Financial assurance plan should be submitted on the basis area put to use for mining, allied activities and in view of above comments.

Plans and Sections

15. The nallah in the lease area is not depicted in the plans and sections. Safety barrier shall be maintained for nallah and proposal shall be submitted accordingly.

16. All the plans and sections should be submitted as per the provision of rules 31, 32 & 34 of MCDR, 2017 and surface plan signed by the surveyor having Certificate of Competency of Survey from DGMS.
17. Proposals shall be submitted in .kml or.shp files in the form of soft copies.
