Sub: Violation of provisions of MCDR, 1988 in respect of Arasmata Limestone mine over an area of 499.987 ha in Arasmata village, Akaltara Mandal & Janjgi-Champa District, Chhattisgarh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection on 25.05.2016 by undersigned in the presence of Sri Ritesh Kaimal, AGM(Mines).

Rule No.	Nature of Violation
13(1)	Mining operations should have been undertaken in accordance with the approved Mining Plan. The Mining scheme was approved vide no.314(3)/2012-MCMM(CZ)/MS-23 on 06.03.2013 for the period 2011-12 to 2015-16 and following deviations observed during the inspection. 1. It was proposed to drill 30 nos core drill holes in scheme period but actually only 20 nos boreholes reported.

02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988. Besides, inability to comply the provision of Rules 13(1) is also liable for suspension of mining operations under the provision of Rule 13(2) of MCDR, 1988.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
