विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Punzoo Limestone Mine, Mining Lease over an area of 3.65 ha located near Village –Punzoo, Tehsil-Doru, District- Anantnag of Jammu & Kashmir-UT.

महोदय Sir,

On examination of the office records following provisions of the Mineral Conservation & Development Rules, 2017 were found violated by undersigned on 28-03-2022 in your above mine:

<u>RULE NO.</u>	<u>NATURE OF VIOLATION OBSERVED</u>
11(4)	The holder of a mining lease shall submit the mining plan to the competent authority for review at least one hundred and eighty days before the expiry of five years period for which it was approved on the last occasion, for mining operations for a period of five subsequent years. Latest Review and Updation of Mining Plan with PMCP was approved vide letter no. 614(2)/MP-B-175/02-DDN, dated 17-05-2017 but lessee has not submitted for the next review till date.
27(2)	Where financial assurance has already been furnished, an amount equal to the difference between the financial assurance due as on the date of notification of MCDR amendment rules 2021 shall be furnished to the authorized officer, within a period of ninety days from the date of MCDR amendment Rules 2021 i.e.02-11-2021 which has not been furnished till date.
35(2) read with 35(4)	Every holder of a mining lease shall monitor his mining and allied activities as per the notified template of star rating in the format prescribed in this behalf by the Indian Bureau of Mines from time to time, and shall submit online its self assessment report before the 1st day of July every year for the previous financial year, to the Regional Controller or the authorized of the Indian Bureau of Mines. Whereas holder of the mining lease has not submitted the online self assessment report as per rules for financial years 2020-21. Further as the star rating template has not been filled by you thus it is considered that you haven't scored any points and thus based on nil points your mine falls under "No Rating" category as per the Criteria for Star Rating mentioned in the notified template.

- In this connection, it is brought to your notice that the violation of rules 11(4) constitute an offence punishable under Rule 62(2) prescribed at Schedule III of MCDR Amendment Rules 2021 and rules 27 & 35 constitute an offence punishable under Rule 62(1) of MCDR Amendment Rules 2021
- Mining operation can also be suspended as per rule 11(2) in case of non-compliance of any Rule/sub-rule of 11 of MCDR 2017.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
