Subject: Violation of provisions of MCDR, 2017, in respect of your Komorrah Limestone Mine (38MEG04001) over an area of 240.55 Ha. in Komorrah Village, Taluka- in Komorrah Village, Taluka- Cherapunjee, East Khasi Hills district of Meghalaya State.

Sir,

On examination of office record, below mentioned rule of Mineral Conservation & Development Rules, 2017 has been found violated in your above mine.

Rule Number	Nature of violations observed
45(5): The holder of a mining lease shall submit online returns in respect of each mine to the Regional Controller or any other authorized official of the Indian Bureau of Mines in the following manner, namely:- (b) A monthly return which shall be submitted before the 10 <sup>th</sup> day of every month in respect of the preceding month in electronic form along with a signed print copy of the same if it is not digitally signed, in the respective Form.	<i>You have not submitted till date the monthly return for the month of March 2020 to the Regional Controller of Mines, Indian Bureau of Mines, Guwahati.</i>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. If the above rules are not complied; The Regional Controller of Mines may advise to State Government to take following action under rule 45(7) (a):


(i) order suspension of all mining operations in the mine and to revoke the order of suspension only after ensuring proper compliance;

(ii) take action to initiate prosecution under these rules;

(iii) recommend termination of the mining lease, in case such suppression or misrepresentation of information indicates abetment or connivance of illegal mining;

04. You are advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty five) days from the date of issue of this letter.


