Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Tiringpahar Manganese Mines over an area of 643.710 hectare in Keonjhar District.

The following provisions of MCDR,2017 were found violated in your above mine during inspection on 29/05/2019 by undersigned along with Shri S. R. Mazumdar, SMG, in presence of Shri Sabyasachi Mishra, Head Mining Planning

Rule No.	Nature of violations observed
11(1)	<ul> <li>Mining operations have not been carried out in accordance to Modification of Review of Mining Plan, approved vide this office letter number MSM/FM/11-ORI/BHU/2018-19, dated 03.07.2018 to the extent given below:</li> <li>1) In 2018-19, a retaining wall and garland drain of 625mx1.2mx1m was proposed around downhill of the dumps but it is observed during inspection that the proposed retaining wall and garland drain have not been constructed.</li> <li>2) In 2018-19, backfilling was proposed in northern side of Gurda-A quarry over 1.2 ha area in the extent of 11508N- 11750N and 11867E- 12128E. However it is observed during inspection that the backfilling not extended latterly in southern part as proposed and height of backfilling is extended more i.e about 700RL while proposal has been restricted to only 690RL.</li> </ul>

- 02 In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of Mineral Conservation and Development Rules, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter. Dayanand upadhyay
