| 11(1) | No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under schedule-A of the Atomic Minerals Concession Rules, 2016.<br><i>The Scheme of Mining of Salaiya Limestone Mining Lease was approved on 06.04.2016 for the proposal period 06.04.2016 to 31.3.2021. As per the approved proposals for the year 2018-19 it was proposed to carry out backfilling in between UTM Grid Coordinates 2666900 N &amp; 2667100 N and 475200 E &amp; 475400 E in the north block (Refer page no 27 and Plan no. 6 Sheet-3of approved mining scheme).</i> |
