

Rule.	Noture of violations observed.
Rule 11(1) of MCDR 2017	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016.

Rule 46	46. Notice of certain appointments.—The holder of the prospecting licence or prospecting license cum mining lease or the mining lease shall,— (a) when any new appointment of an agent, mining engineer, geologist or any person is made under sub-rule (1) of rule 55; or (b) when the employment of any such person is terminated or any such person leaves the said employment; or (c) when any change occurs in the address of any such person, within fifteen days from the date of such appointment, termination, leaving or change in address, give a notice in Form H of the Schedule to the authorised officer, as the case may be.
