The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during MCDR inspection on 27/01/2020 by the undersigned in presence of Owner's representative, Mr SP Sharma .S r GM -Geology.

Rule.	Nature of violations observed.
Rule 11(1) of MCDR 2017	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016.  1.Development and production are very less than planned quantities.(yr 18-19)  production topsoil overburden  Plannned: 908732T 137103M3 (1823)M3 427733  Actual: 2238T nil 1,16,273 M3
	2. Backfilling is not done over an area of 3.256 hect as per approved plan.
Rule 46.	46. Notice of certain appointments.—The holder of the prospecting licence or prospecting license cum mining lease or the mining lease shall,— (a) when any new appointment of an agent, mining engineer, geologist or any person is made under sub-rule (1) of rule 55; or (b) when the employment of any such person is terminated or any such person leaves the said employment; or (c) when any change occurs in the address of any such person, within fifteen days from the date of such appointment, termination, leaving or change in address, give a notice in Form H of the Schedule to the authorised officer, as the case may be.  Notice with respect to appointed geologist and mining engineer for the mines is not submitted to this office.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
