Subject: Violation of provisions of provisions of Mineral Conservation & Development Rules, 2017
in respect of your **Lugma-Ukwa Manganese Mine (69.851 Hect.)** in Balaghat district of M.P. State.

Dear Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during Stopping inspection/MCDR inspection on 17/01/2020 by the undersigned in presence of Mr.Pathak, Mines Manager.

Rule.	Nature of violations observed .
Rule 55 of MCDR 2017	Employment of geologists and mining engineers.-(1) For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules,- 1. every holder of reconnaissance permit shall employ a whole-time geologist; 2. every holder of prospecting licence or a prospecting license cum mining lease shall employ a whole-time geologist and a part-time mining engineer; 3. every holder of a mining lease shall employ, in case of- (iii) category 'A' mines, a whole-time mining engineer and a geologist; (iv) category 'B' mines, a part-time mining engineer and a part-time geologist: Mr Rangdale is appointed as geologist in mine as per return submitted.It is observed he holds appointment in other mines.A full time geologist is not appointed as per rule for the mines.
Rule 26(2) MCDR 2017	(2) The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof: Statement for progressive closure in this rule is not submitted.

02.In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.

03 .You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
