The following provisions of Mineral Conservation & Development Rules 2017 were found violated in your above mentioned mines in during the MCDR inspection on 12/12/2019 by the undersigned in presence of Mr.

VS Chande, Manager FMCP	
Rule.	Nature of violations observed .
11(1) of MCDR 2017	Mining operations under mining lease.—(1) No holder of a mining lease shall commence or carry out miningoperations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureauof Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals. Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016. The exploration proposed in approved plan for four number of boreholes(page 21) is not done and no report is submitted to this office for same.
28 of MCDR 2017	Copies of plans and sections to be submitted.— The holder of a mining lease shall, on or before the 30th day of June every year submit to the authorized officer, as the case may be, and the State Government, a digital copy along with a print copy of the surface geological plans and section maintained under rule 32. A copy of surface geological Plan and Sections maintained under rules was not submitted to this office.
26 of MCDR 2017	Responsibility of holder of a mining lease (1) The holder of a mining lease shall have the responsibility to ensurethat the protective measures including reclamation and rehabilitation works have been carried out in accordance with theapproved mine closure plan or with such modifications as approved by the competent authority. (2) The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof: The statement under above rule has not been submitted for your mine for year 18-19.

02.In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.

03. Further it is informed that the mining operations can be suspended under rule **11**(2), if compliance of rule **11**(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within

45 (Forty Five) days from the date of issue of this letter.
