Violation of provisions of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Ukwa Manganese Mine (199.0673 Hect.) in Balaghat district of M.P. State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during MCDR inspection on 05/03/2020 by the undersigned in presence of Mr.Pathak, Mines Manager.

Rule.	Nature of violations observed .
Rule 26(2) MCDR 2017	(2) The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof:
	Statement for progressive closure in this rule is not submitted.
Rule 46 MCDR 2017	46. Notice of certain appointments.—The holder of the prospecting licence or prospecting license cum mining lease or the mining lease shall,— (a) when any new appointment of an agent, mining engineer, geologist or any person is made under sub-rule (1) of rule 55; or (b) when the employment of any such person is terminated or any such person leaves the said employment; or (c) when any change occurs in the address of any such person, within fifteen days from the date of such appointment, termination, leaving or change in address, give a notice in Form H of the Schedule to the authorised officer, as the case may be.
	Notice for appointed mining engineer in mines is not submitted under above rule. If it is found that the holder of a mining lease or the person or company engaged in trading or storage
Rule 45	or end-use or export of minerals, as the case may be, has submitted incomplete or wrong or false
MCDR 2017	information in daily or monthly or annual returns or fails to submit a return within the date specified; then,
	Provided that the holder of a mining lease or the person of company engaged in trading of storage or end user or export of minerals, as the case may be, referred to in clause (a), (b) and (c) above, shall be informed in writing about the violation and if the violation is not rectified within a period of forty-five days, a show cause notice shall be given asking reasons why the mining operations should not be suspended and, further, if no satisfactory reply is received within a period of thirty days, the mining operations may be suspended. 1.The name of geologist is not correct. 2. information on land use pattern is not complete as given in FA table.
	3. figures of reserves have not been updated upto end of FY 18- 2019.

02.In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.

03 .You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of Issue of this letter.
