The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned in presence of Shri. Vinod Kumar- Manager Mining & Shri. Nataraj Belgere - Geologist on 25.02.2020.

	As per Part I, Sl No.12, in lease area (surface area) utilization at the end of the year, 6.85 Ha has been shown as already exploited & abandoned by opencast mining where as no area is fully exploited and abandoned & nor any such proposal is given in the approved mining plan.
55	In case of fully mechanised category 'A' mines, the mining engineers shall have minimum five years of professional experience of working in a supervisory capacity in the field of mining.  Mining Engineer appointed does not possess the requisite experience.
	wining Engineer appointed does not possess the requisite experience.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
- 03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
