विषय/Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your John Mine (ML No. 2294) over an area of 42.13 Ha located in Meghalahalli,Tanigehalli & Chowdwnahalli village, Chitradurga & Holalkere Taluka, Chitradurga district of Karnataka State

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned in presence of Sri Ranadive. N - Manager Mining, Shri. Dhananjaya G. Reddy - Mining Engineer & Shri. Deepak.CA - Geologist on 11.03.2020

Rule	Nature of violations observed
11(1)	RMP with PMCP was approved vide letter no.279/174/90/BNG/1830 dated 09.11.2016 for a period of 2017-18 to 2021-2022. The deviation observed in mining operation vis-a-vis approved document are given below Working was proposed from RL 959 mts in the northern side of the pit in FY-2018-19, whereas actual mining was carried out from RL-954.5, thereby deviating from the proposals.
45 (7)	Following deficiency was observed in the Annual Returns submitted for the year 2018-19 In Part – V, sec 3, under Reserves and Resources estimated at the end of the year, 34 Million Tons (30 Million -proved and 4 million- probable) is reflected under Reserves category, where as only 29.22 Million Tons (28.86 million -proved and 0.36 million -probable) is available.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.

03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
