विषय/Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your of Karigala Kyanite Mine (ML No. 2286) over an area of 12.14 Ha located in Karigala village, HD Kote Taluka, Mysore district of Karnataka State.

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned in presence of Shri., C P Prasanna Kumar-Qualified person & your good self on 06.02.2020.

Rule	Nature of violations observed
11(1)	Scheme of Mining was approved vide letter no.279/635/99/BNG dated 11.06.2015 for a period of 2016-16 to 2019-2020. The deviation observed in mining operation vis-a-vis approved document are given below:
	i)Production & development was proposed in Pit No.5 in between grid lines E658350- E658400, N1345150- N1345500, where as actual production was carried out in Pit No.1 & 2, in between grid lines E658000N1345250 & E657952N1345268 and E657946N1345367 & E657973N1345346 ii)Achieved the stripping ratio of 1:1.50 against the proposal of 1:2.12 iii) working was proposed in one pit namely no.5, whereas actual working was going on in two pits, Pit no.1 & pit No.2 iv) Environmental monitoring of air water & noise was not carried out.

26(2)	Yearly report on PMCP setting forth the extent of protective and rehabilitative works carried out as per the approved Progressive Mine Closure Plan has not been submitted.
45 (5)(c)	The holder of a mining lease shall submit online returns in respect of each mine to the Regional Controller or any other authorised official of the Indian Bureau of Mines an annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same if it is not digitally signed. Annual returns have not been sent to this office for the year 2018-19.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
- 03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
