विषय /Subject: Violation of provisions of MCDR 2017 in respect of your Janikunte Iron ore Mine, ML No. 0011 over an extent of 44.42 Ha. located in Janikunte Village, Ballari Taluk & District of Karnataka State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 16.03.2022 by the undersigned in the presence of Sri Syed Farooq, Agent, Shri Gururaj , Mines Manager , Sri Kiran Kumar, Mining Engineer and Sri Suresh R. Khot, Geologist.

Rules	Nature of Violations observed
45(7)	<p>i) As per provision of Rule 45(5)(b) " a monthly return shall be submitted before the tenth day of every month in respect of the preceding month in electronic form". The monthly Return for the month of October, 2021 has been submitted on 10<sup>th</sup> November, 2021 which is after the due date.</p> <p>ii) The online Annual return for the year 2020-21 has been submitted by the Lessee; Following discrepancies are noted in the submitted copy as observed during site inspection.</p> <p><b>Part-III A</b> : The value of Fixed Assets has not been reported correctly.</p> <p><b>Part-V.3</b> : The Reserves have not been reported correctly.</p> <p><b>Part-VI</b>: The Ex-mine price reported in Part-VI (3) has not been reported correctly. In case of Captive mines, the Ex-mine price per tonne is the per unit cost of production.</p> <p><b>Part-VII</b>: (a) The production proposal for financial year 2020-21 is to be reported correctly.</p>

02. The Mining operations and dispatches may be suspended and any action under subrule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.
03. In this connection, it is again brought to your notice that this violation also constitutes an offence punishable under Rule 62 of MCDR (Amendment), 2021.
04. **You are therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why action under subrule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.**
05. You are herewith given 30 days time for reply and rectification of the violation from the date of issue of this notice. The fine for the late submission of monthly return is to be made immediately as per Schedule-II of MCDR (Amendment) Rules, 2021. Please note that no further notice will be given to you in this regard.
