Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Jajang Iron & Manganese mine, over an extent of 666.150 hectare in Keonjhar District.

Sir,

The following provisions of MCDR,2017 were found violated in your above mine during inspection on 12/06/2017 by undersigned alongwith Shri Dilip Jain Junior Mining Geologist in presence of Sri A.C Biswal, AVP(Mines) & Sri S.Sekhar, Abhijit Sen, Qualified Persons.

Rule No.	Nature of violations observed
11(1)	Mining operations have not been carried out in accordance with the Modified Mining Plan, approved vide this office letter number MPM/FM/09-ORI/BHU/2016-17 dated 19.03.2016 to the extent given below: 1) It has been observed that in B-block pit, the benches have not been developed as proposed between grid line N2100 to N2300. 2) Sub grade/Low grade dump was proposed to stack near southern part of wastedump-2 near crushing and screening unit. Whereas it is observed during inspection that an additional low grade dump-4 has been formed near waste dump-2. 3) In 2016-17 the backfill was proposed in south western part of the lease between pillar 44C & 47. Whereas it is observed during inspection that the backfilling is extended towards northern side to the grid line N-300 against the approved proposal.

02 In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
