Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Karadikolla (Suresh) Iron Ore Mine (ML No. 2502) over an area of 42.10 Ha located in Karadikolla village, Sandur taluk, Ballari Dist., Karnataka State

Sir,

The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned in presence of Shri. Y.V.RamaKrishna Reddy, Manager Mining and Shri. J.Vijay Narasihulu, Mining Engineer on 07.06.2018.

<b>Rule</b>	<b>Nature of violations observed</b>
11(1)	(a) As per the approved document vide letter No.279/27/89/BNG dt 27.11.2017 working was proposed in grid reference N1683560 to N1684125 & E653460 to E653825.It was observed that working was not carried out towards the eastern side of the lease in between grid lines N1684350 to N1684400 & E653850 to E653900.  (b) As per the Progressive Mine Closure Plan 2835 saplings were proposed but in actual only 1100 saplings have been planted.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.

03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
