54 (c)	Holder of mining lease shall maintain the sub grade or mineral reject stack register along with grade.	During inspection it is observed that sub-grade or mineral reject stack register along with grade not maintained.

02. It is brought to your notice that these violations constitute an offence punishable under Rule 62 of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within **45 (forty-five) days** from the date of issue of this letter.
