Details of violations observed during current inspection and compliance position of earlier violation pointed out:

The last MCDR inspection was carried out on 03.06.2016 and violation of rules 12(3), 13(1), 24, 42(1)(b)(ii), 45(5)(a)(vi), & 45(5)(b)(vi) were pointed out. As per office records, party complied the rule 45(5)(a) & 45(5)(b)(vi) and rest not complied.

Further, on scrutiny of office records IBM, Hyderabad, Violation cum Show cause Notice has been issued to party for violation of rules 12(3) & 13(1) on 19.12.2012. But party not complied the rules and mining operations were suspended by RCOM, IBM, Hyderabad vide letter No. 10(10)/NLR/11/HYD dated 29.01.2013 for non compliance of violations pointed out.

During current inspection contravention of rules 11(1), 11(4), 27(2), 45(5)(b)(i) & 45(5)(c)(i) of MCDR, 2017 were observed and accordingly draft violation letter is being sent to RCOM, Secunderabad for further action
