In this regard, party complied only rule 45(1) & (2). Due to non compliance of the rules, the mining operations were suspended by RCOM, IBM, Hyderabad vide letter No. 10(10)/NLR/11/HYD dated 11.07.2012 for non compliance of violations pointed out.

During current inspection contravention of rules 11(1), 11(4), 20, 27(2), 45(5)(b)(i) & 45(5)(c)(i) of MCDR, 2017 were observed and accordingly draft violation letter is being sent to RCOM, Secunderabad for further action
